We refer to our letter dated 16th January, 2019 wherein the Company had informed the exchanges that the next date of hearing is 28th January, 2019 before the National Company Law Tribunal, ('NCLT') Mumbai bench in the proceedings initiated by Union bank of India under the Insolvency and Bankruptcy Code.

We would like to update that the Hon'ble NCLT had in its hearing dated 28th January, 2019 placed on record a copy of the draft proposal for settlement submitted by the Company.
